



### Merits of Listing an SME IPO



#### **BSE SME Listing Metrics#**

### Listing criteria & conditions:

Post issue paid up capital must not exceed 25 crores
Net worth should be at least ₹1 Cr in each of the last 2 full financial years.
Net tangible assets should be at least ₹3 Cr in the preceding full financial year.
The track record of applicant company seeking listing should be at least 3 years.
Positive cash accruals (EBITDA) must be recorded in at least 2 out of the last 3 completed financial years.
Leverage ratio post-IPO should not exceed 3:1, with relaxation possible for finance companies.
Minimum promoter dilution of 26.25%, with 25% to the public and 1.25% to the market maker.
At least 50 investors are required as minimum subscribers.
100% underwriting is mandatory for the IPO.
Market making is compulsory for a period of 3 years.
Migration to the main board is allowed after 3 years subject to satisfaction of migration conditions.
The trading lot size must is a minimum of ₹1,00,000.


