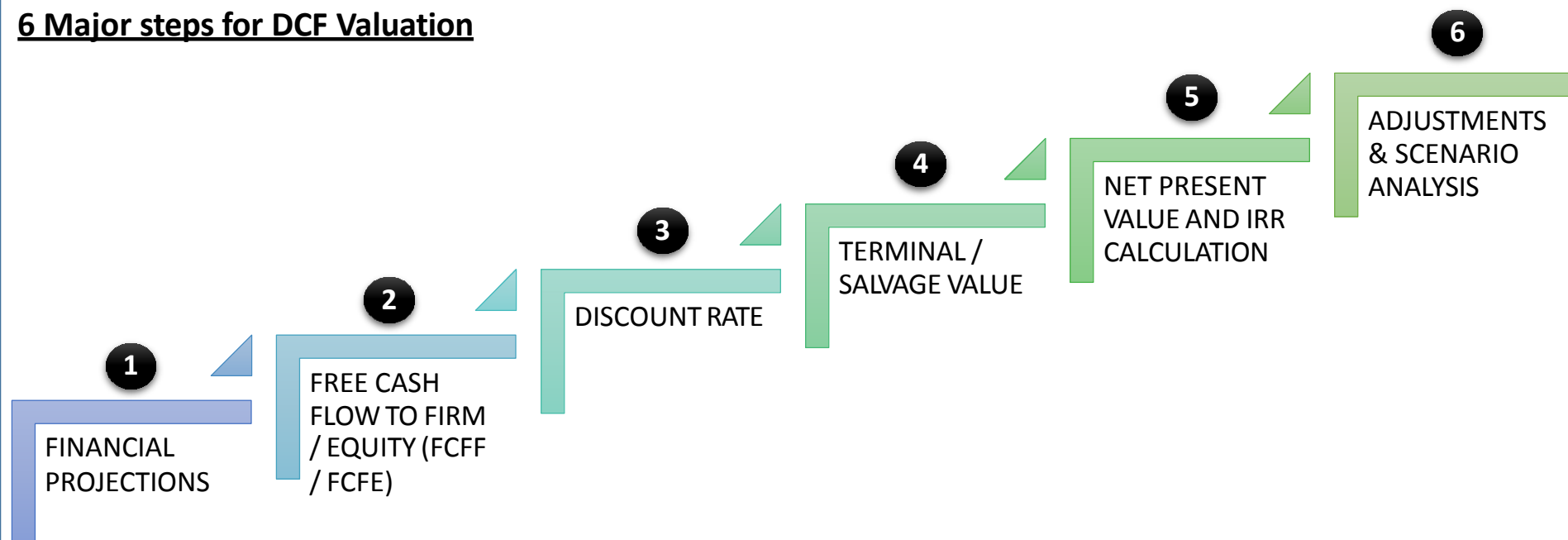
# Service Offerings (2/2)

## VALUATION SERVICES

**Only Merchant Bankers are entitled to do valuation of unquoted shares.** Central Board of Direct Taxes (CBDT) made alterations, vide its notification, in Rule 11UA(2)(b), which allowed Merchant Bankers for carrying out valuation of the equity shares using Discounted Cash Flow (DCF) method. Therefore, if a closely held company is desirous of issuing further shares and wants to get it valued under DCF, ***then it will have to get it done by merchant bankers only.***

Valuations are required for different circumstances and the purposes such as investment analysis, capital budgeting, merger and acquisition transactions, financial reporting, taxable events to determine the proper tax liability for which the valuation is intended. ***Kreo Capital posses the requisite manpower and resources for providing pro-eminent services, which are tailored to meet the needs of clients at different stages of development and with different objectives.***
